International Inspection Deposit includes all travel overheads, plus AU\$990 per day for estimated number of inspection days.

Please Note: This assumes a normal 8.5 hour day. Additional hours will be invoiced to operator.

PLUS AU\$530/day for estimated number of travel and report/writing days. Post Inspection fee includes any tests required, NCO review fee based on AU\$170/hour and any adjustments for travel, inspection and report-writing. Reduced inspection day rate of AU\$650 applies if Inspector is resident in the country of the operator. Annual International Inspection Deposits are payable by the operator 4 weeks in advance of scheduled inspection date. Please note: In cases where international inspections are outsourced to a contracting certification body, the inspection fee may be separately charged by the outsourced certification body, based on its fee schedule.

NOTES AND PAYMENT TERMS

- Fees and Levies are non-refundable.
- Additional fees apply for 'fast track service'; additional inspection for parallel production operators; unannounced inspection costs where nonconformities are found; testing; and may apply for additional acreage and products depending on when in the renewal cycle they are brought in.
- Advance payments or deposits for inspections are generally refundable if application is cancelled prior to inspection (only where bookings have not been made).
- Pro-rata portion of Annual Fee is charged in first year from date of contract issue to end of financial year.
- Annual Fees will be invoiced during July. Levy, if applicable, is payable during January on sales made under certification in the previous calendar year.
- Testing fees are subject to laboratory prices at the time of lodging samples.
- Terms are strictly 30 days unless otherwise stated on invoice.
- Goods & Services Tax (GST) is not charged for international-based operators.
- Late Payment Fee of \$65.00 may be applied to all invoices not paid by due date.
- Domestic Producer, for producers who sell directly to Australian consumers only, with gross sales not exceeding \$40,000, and not selling into wholesaling and processing chain.
